

#### EXCESS VALUATION CHARGE

A fee of .600 per \$100.00 of declared value will be assessed on those shipments having a declared value exceeding \$.50 cents a pound.

#### SCHEDULE OF C.O.D. FEES

There will be a \$10.00 minimum collection fee charged for the collection of C.O.D. funds of \$1000.00 or less by the Carrier Any C.O.D. amount over \$1000.00 will be charged at the rate of 1/2 of 1% of C.O.D. amount collected. Maximum charge of \$150.00

#### BULKY SHIPMENTS

All shipments, regardless of their commodity description, will be subject to the provisions as contained in this item and as such, the charges for the transportation thereof will be based upon the actual aggregate (total) weight or the computed weight, whichever is greater. Computed weight, as referred to herein, will be determined by multiplying the three extreme rectangular (or equivalent) dimensions in inches of the packages to determine the cubic inch content. The cubic inch content will then be divided by a factor of 200 cubic inches per pound to arrive at the computed weight. In determining the three dimensions for the computation of computed weight of a shipment, fractions of an inch will be increased to the next higher whole inch.

#### EXCLUSIVE USE VEHICLE

When requested by the consignor or consignee, Emergency, Special or Extra Service, not following the routine of the carrier in the regular performance of his business, but requiring delivery by motor vehicle, will be provided and charged for upon a special basis. # DECISION MC-18772 EP SOUTH WEST LOGISTICS INC D/B/A SOUTH WEST LOGISTICS EL PASO, TX REENTITLED EP SOUTH WEST LOGISTICS INC. D/B/A ROAD SKY EXPRESS

On January 20, 2023, applicant filed a request to have the Federal Motor Carrier Safety Administration's records changed to reflect a name change.

#### It is ordered:

The Federal Motor Carrier Safety Administration's records are amended to reflect the carrier's name as EP SOUTH WEST LOGISTICS INC., D/B/A ROAD SKY EXPRESS.

Within 30 days after this decision is served, the applicant must establish that it is in full compliance with the statute and the insurance regulations by having amended filings on prescribed FMCSA forms (BMC91 or 91X or 82 for bodily injury and property damage liability, BMC 34 or 83 for cargo liability, or a BMC 84 or 85 for broker security and BOC-3 for designation of agents upon whom process may be served) submitted on its behalf. Copies of Form MCS-90 or other "certificates of insurance" are not acceptable evidence of insurance compliance. Insurance and BOC-3 filings should be sent to Federal Motor Carrier Safety Administration, 1200 New Jersey Ave., S.E., Washington, DC 20590.

The applicant is notified that failure to comply with the terms of this decision shall result in revocation of its operating rights registration, effective 30 days from the service date of this decision.
